

Long-term consultancy assignments

Here follows a list assignments that I have had that did not result in any publication, such as an evaluation report, or a written organisational or policy analysis. In these cases, my role was to provide advise on monitoring, evaluation, quality control organisational development over a longer period of time, under a framework agreement with the organisation mentioned.

<u>The Nordic Development Fund</u>, Helsinki. The Nordic Development Fund is a multilateral agency that provides credits for projects in the developing countries. It is jointly owned by the five Nordic countries, and located in Helsinki. Since 2001, I have a framework agreement to assist with advice on the design of an evaluation policy and implementation of systems of performance management, monitoring and evaluation.

<u>Statskontoret, (The Swedish Agency for Public Administration,)</u>, Stockholm. In January 2001 the Ministry of Justice initiated a project whereby 24 public agencies (including the tax authorities, the social security offices, the customs authorities, the agriculture board, and several others) were to develop service declarations and service dialogues linked to organisational development. It was a 2 year project, coordinated by Statskontoret and Statens kvalitets- och kompetensråd. The project was to be evaluated and my role was to assist with the design and implementation of a process of participatory evaluation with the 24 organisations involved, leading to a consolidated evaluation report in March 2003 (Lyssna för att lära och lova. Utvärdering av en försöksverksamhet med servicedialoger och serviceåtagande. Statskontoret 2003.9, also available at www.statskontoret.se). In 2004

a new project of service coordination between five public authorities (tax authorities, social security, and others, was initiated, and I had a 2 year framework contract to assist with the evaluation of this project. The full program can be seen at the same web address as above, under the subtitle of "VISAM". During 2008 I assisted in the pilot project to develop a new model for assessment of public authorities (myndighetsanalyser). The final report was presented to the government in December 2008. During 2010 I took part in an analysis of the Regional Authority in Kalmar (Myndighetsanalys av Länsstyrelsen i Kalmar Län), which was presented to the Ministry of Finance in June 2010.

<u>The Foundation for Strategic Environmental Research</u>, Mistra, Stockholm. The Foundation funds environmentally oriented research. It has an evaluation policy whereby each research project is subjected to an impact assessment at the time of a first application, in case of an application for second and third phase of research, and when the project is completed. My role is to assist with methodological advice to Mistra, as well as to advice independent evaluators (who are mostly chosen because of their knowledge of specific technical subject areas) on issues of evaluation methodology. My assignments for Mistra started in 2003.

Export Music Sweden AB is an organisation set up to promote the export of Swedish music; pop, rock, jazz, classical and all other genres. ExMS is funded by the associations of recording companies, publishing houses, as well as by the Swedish collection Society, STIM. Since 1999 I have had an agreement to monitor the export performance of the Swedish music industry. This builds on a method of data collection through official statistics, annual reports of companies, and interviews, that I designed in 1998. Reports have been published every year from 1999 up to 2003. They are available www.exms.com

<u>Expert Panel</u> on the evaluation of development cooperation from the European Commission. The evaluation unit for development cooperation has a three-year program to develop policy, training materials, processes and structures for evaluation. An expert panel was appointed to advise on progress. It has six members, and met once a year between 2003 and 2005, and I was one of the six members.

<u>EuropeAid</u>. In 2003 the European commission invited tenders for a three year framework contract to develop methodologies in this respect and to also undertake evaluation of country strategies. A consortium of French and German companies won the tender, and I was one of the evaluation team members. My part was to work with the development of the methodological approaches to country strategy evaluation, to report on good practice from other organisations in development cooperation and to assist in quality control.

<u>The Ministry of Education</u>, Stockholm. During the latter half of 2009 Sweden was the Chair of the European Union. The Swedish government was set to evaluate its performance during the chairmanship, and the Ministry of Education entered into a framework agreement with me for methodological advice and support, starting with the planning of an evaluation, methodological choices, implementation and support to the Ministry in conduction the evaluation, and setting standards for achievement. The contract started in mid 2008 and continued until the Ministry's final reporting in 2010.

<u>Macro-evaluation of DFID's policy frames 'Empowerment and Accountability' and 'Gender Equality'</u>. This is a collaboration with the consulting firm Itad, based in Brighton, to be part of team managing these two maco-evaluations. I joined the proposal to DFID as team leader, which function I had during the inception phase. The team has since been reorganised and I took part as methodological advisor 2015.

<u>Facilitator, the IDA 17 Working Group on Results</u>. The World Bank IDA17 replenishment lasts from 2014 - 2016, and during that time a Working Group of Deputies to the World Bank and senior management is set up to contribute to results management. The Working Group is co-chaired by Kenya, Sweden and the UK. Andante - tools for thinking AB has a contract with DFID to facilitate the meetings of the Working Group during the IDA 17 replenishment period. Apart from taking part in discussions on the agenda, providing advice on external resources, providing concept notes etc. as requested by the Group, the assignment includes undertaking a feedback study on results cultures in a sample of borrowing countries.

<u>Quality control and technical assistance on evaluation methodology for DFID.</u> A framework contract over a longer period of time to participate in DFID's pool of technical expertise for external quality assurance of major evaluations (mandatory in DFID) and provision of selected technical expertise according to demand. This translates into series of smaller requests for reviews, usually 3 - 4 days for each evaluation, sometimes more for methodological support relating to the design of evaluations and assessment of Inception reports. Estimated to last through 2016.

Most of the work that I do end up in some form of publication, either an evaluation report, a study for those who commissioned the work, or as research papers and books. Summary

Chance and luck gave me an opening job with the building contractor Skanska in Ethiopia in 1971 and 1972. The experience of being in Ethiopia on the brink of revolution stimulated an interest in development issues that have been with me since. Several years later I was working for the UNDP in Tanzania, which provoked an interest in matters of organisation, governance and management. It is at the converging point of these two fields of study that I have my education, my professional experience and my broad interest as a researcher and consultant.

I took a first degree in business administration and economics at the Stockholm School of Economics, following which I became a research associate at the Institute of International Business. While pursuing research in evaluation and organisation science, I was teaching scientific method, as well as international management. My Ph.D. study on planning and evaluation was published in 1985.

A formative period in my professional life was a year spent at the Wharton School, the University of Pennsylvania, where I followed a programme in Social Systems Sciences. The approach to interdisciplinary research taught there, its sharp focus on systems properties, and practical training in holistic approaches have been ideals for me since then. The programme gave me an interest in large, messy and unstructured problems, which remains.

The core of my professional interest lies in evaluation research, that is, in the study of evaluation processes, in finding solutions to evaluation questions, and in developing sound methods of evaluation. But evaluation is part of larger organisational processes; such as creating legitimacy, boundary management, organisational learning, management, control and governance. In pursuit of evaluation, I have also come to read on, think about and work with these areas.

I have mainly applied knowledge in evaluation to development cooperation. It is the process of cooperation as such, with its structures of governance, accountability, learning and control that have been at the centre of my interest, and where I have worked, for example through appointment to several Parliamentary Commissions, to Executive Boards in the Swedish aid community, as well as research and consultancy assignments in Sweden and abroad. These have covered both bilateral and multilateral development cooperation, but on balance I have spent more time on the international organisations, reform issues in the UN system, and organisational change in complex, intergovernmental systems.

Even though international cooperation is at the centre, I have worked in many other sectors, as in the music industry, on museums and cultural policy, public health organisations, defence and several other fields of public administration and research.

Sammanfattning

Eftersom min curriculum vitae inte är så lättillgänglig kommer här några rader om vad det är jag gör. När jag får frågan vad Andante – tools for thinking är för typ av företag, brukar jag säga att det har en inriktning på *forskning, utbildning och rådgivning om styrning, samordning och utvärdering i komplexa organisatoriska miljöer.* Det är inte ett glasklart svar, men det avspeglar verkligheten. Tonvikten skall ligga på forskning, utvärdering och komplexa organisatoriska miljöer.

Genom årens lopp har jag arbetat särskilt mycket med internationella organisationer, med tonvikt på FN-systemet. Mitt avhandlingsarbete (som lades fram vid Handelshögskolan 1985) behandlade planerings- och utvärderingssystem, bl.a. inom UNDP's landprogrammerade bistånd. Under senare år har jag lett en utvärdering av ett ILO program för stöd till småföretagande, och jag har arbetat för UNDP's utvärderingsenhet med metodutveckling på utvärderingsområdet, och t.ex. utarbetat moduler för personalutbildning. Jag deltog i en omfattande internationell utvärdering av UNDP. Tillsammans med två forskare vid Karolinska Institutet gjorde jag en översyn av världshälsoorganisationen, WHO, vilket leder till reformförslag som Sverige driver i skilda internationella sammanhang. Jag har även arbetat för UNICEF, och senast med en utvärdering av UNESCO på uppdrag av dess styrelse. Under 2014 – 2015 deltog jag i arbetsgruppen för resultat i Världsbankens, (IDA 17) styrelse.

Jag har också varit anlitad som konsult och sakkunnig i flera organisationsutredningar inom svenska och internationellt bistånd, t.ex. avseende utvärderingsfunktionen, styrning och samordning, och nu senast Expergruppen for Biståndanalys (www.eba.se). Utvärderingsområdet är intressant i sig, och mina aktiviteter där faller i tre kategorier; (1) utvärdering av enskilda projekt och program (många av dessa redovisas i min cv), (2) arbetet med metodutveckling på utvärderingsområdet, t.ex. genom att utveckla nya metoder för att mäta utbildningseffekter, utveckling av metoder för "participatory evaluation", samt undervisning i utvärderingsmetodologi; samt (3) forskning och konsultuppdrag kring hur utvärderingsfunktioner kan byggas in i organisationer och bidra till effektivitet, lärande och styrning.

I Sverige har jag arbetat med olika delar av förvaltningen, men främst med regeringskansliet och det statliga utredningsväsendet. Jag har deltagit i flera olika utredningar som sekreterare, sakkunnig, expert eller som anlitad konsult och utvärderare. Jag har gjort en egen utredning om kvaliteten i utredningsväsendet, och utvecklat en modell för kvalitetsbedömning. Åren 1999 och 2000 gjorde jag en utredning om regeringskansliets dimensionering. Även om uppdragen i den svenska förvaltningen avsett många olika områden eller sektorer, är det dock själva utvärderingskompetensen och analysen av styrning, samordning och lärande i komplexa organisatoriska miljöer som har varit mina bidrag – vare sig det specifika uppdraget avsett musikexport, försvar, kulturpolitik, hälsovård, eller någon annan sektor.
